

Registration is now open for the 2025 Liberation Day hampers in Guernsey

Registration is now open for the 2025 Liberation Day Hampers in Guernsey.

Collas Crill is once again partnering with the States of Guernsey's Committee for Education, Sport & Culture to give away 500 Liberation Day tea hampers to islanders aged 80 or over who were in Guernsey or evacuated during the Second World War, as part of the celebrations of the island's 80th year of freedom from German occupation.

Each hamper contains a Guernsey biscuit, buttermilk cake, Guernsey chocolate, tea, cheese, butter and milk. The hampers are available through the support of Collas Crill and the donation of butter and milk from the Guernsey Dairy.

Who can register?

Residents of the population who:

- are aged 80 and over
- were living in Guernsey or evacuated during the Second World War
- are living in private accommodation or with family (a separate initiative is being run for those people living in care/residential homes)

You can register for a hamper for yourself or can give consent to someone to apply and collect on your behalf - hampers will only be given to those people who have registered. One hamper per person can be claimed.

If you are applying on someone's behalf, or someone else is collecting on your behalf, please also include the following **additional** information:

- Your name / name of person collecting the hamper
- Your telephone number / telephone number of person collecting the hamper
- Your email address / email address of person collecting the hamper

What's the deadline?

Registration for the hampers runs until Monday 28 April.

When do we collect our hamper?

Staff from Collas Crill will be handing out the hampers, which will be available for collection from **Beau Sejour between 8.30am and** 11:30am on Friday 9 May.

The team from Collas Crill look forward to seeing you.

Just a few pointers to note

- There is no need to come earlier than 8.30am it's not 'first come, first served' as we have enough hampers for everyone who has registered.
- Hampers are only available for people who have registered.
- Only one hamper per person can be claimed.
- Whether you are the recipient or collecting on behalf of someone else, you must bring ID with you when you come in to collect your hamper.
- Unless you hold a Blue Badge there is strictly no parking or waiting at the entrance area of Beau Sejour. Please use the main car park. If you need assistance carrying your hamper to your car, this is available.
